RE: Brandon Capital Pty Limited – Change in Substantial Holding - Osprey Medical, Inc. (OSP) ('Osprey' or 'the company')

The purpose of this notice is to confirm the dilutive impact of the issue by Osprey of 38.5 Million CHESS Depositary Interests (CDIs) (Tranche 1 of the Placement announced by Osprey on 4 August 2016 and 11 August 2016) on the holdings of Brandon Capital Partners Pty Limited and the funds listed below (Brandon Capital Partners) in Osprey.

Brandon Capital Partners, a 16.1% CDI holder in Osprey (pre-Tranche 1 of the Placement), has committed A\$10 Million to be invested in Tranche 2 of the Placement. Tranche 2 will consist of approximately 61.5 Million CDIs to be issued subject to stockholder approval at a special meeting of stockholders to be convened by the Company on or about Tuesday, 30 August 2016.

The ASX will be advised of the increased holdings in Osprey by Brandon Capital Partners following the allotment of the CDIs under Trance 2 of the Placement, on or around 6 September 2016.

## **Previous notification**

Brandon Capital Partners last advised Osprey of a change in holdings of CDIs in Osprey on 31 March 2015. A summary follows below:

## **Present relevant interests**

38,540,000 CDIs were allotted on 11 August 2016 in accordance with announcements by Osprey to the ASX on 4 August 2016 and 11 August 2016. The allotment of CDIs on 11 August 2016 diluted the holdings of Brandon Capital Partners in Osprey. The table below shows the revised percentage changes in voting power resulting from this issue.
