## Resignation of CFO & Co. Secretary

Mr Mark Waller has informed the company of his intention to resign his position as Chief Financial Officer and Company Secretary of Empired Limited effective 2<sup>nd</sup> of May 2016 with his services retained through to 31 October 2016.

Mark joined Empired over 11 years ago, at which time the company had circa 15 full time staff and services revenue of approximately \$2m.
