RCR AWARDED OVER \$130M IN NEW CONTRACTS

Integrated engineering and infrastructure company RCR Tomlinson Ltd (ASX: RCR) is pleased to announce that it has been awarded over \$130 million in new projects and contract extensions.

The successful project awards include:

Transport for New South Wales ("TfNSW") - Rail Infrastructure Projects – design, construction and commissioning of new electrical traction power at Chalmers Street and Granville Junction substations and provision of high voltage ("HV") traction feeder supply upgrades for TfNSW. The contracts awarded to RCR and its consortium partner are valued at over \$64 million (RCR's share of the works is valued at \$40 million). Work will commence immediately on these three projects.

In addition, the Novo Rail Alliance has been awarded a contract for rail upgrade works to increase the capacity of the North Shore line valued at \$65 million. The North Shore line rail upgrades include changes to track, overhead wiring and signalling configuration as well as associated civil, building and power works. The Project is strategically important for TfNSW as it will improve the reliability of trains for customers travelling on this line.

Newcrest Cadia Operations - construction contracts at Newcrest Mining Limited's Cadia Valley Operations in New South Wales valued at \$25 million. RCR has been engaged to deliver design, construction, testing & commissioning of a new materials handling facility and other associated mine infrastructure works at the mine. Preliminary work is underway and the project is due for completion in the September Quarter of 2016.

Victorian Department of Health and Human Services - a two year extension to RCR's existing maintenance service agreement with the Victorian Department of Health and Human Services, valued at \$38 million. The extended contracts commence from 1 July 2016.

RCR's Managing Director & CEO, Dr Paul Dalglish said "It is pleasing to see these contract awards coming through reflecting infrastructure spend from State Governments and in particular the rail sector. The excellent long-term relationship RCR has with these clients is a result of a history of successful and safe delivery. Repeat customers are our most valued clients and both Newcrest and State Governments will continue to have on-going work which is very attractive to RCR."
