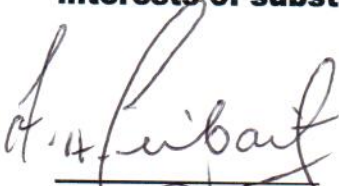
DIRECTIONS
