The securities of Asciano Limited (the “Company”) will be suspended from quotation at the close of trading today, Friday 29 July 2016, at the request of the Company, following lodgement with ASIC of the court orders approving the scheme of arrangement between the Company and its shareholders in connection with the acquisition of all of the Company’s shares by Australian Logistics Acquisition Investments Pty Limited.

**Asciano Limited (ASX: AIO) – request for suspension of trading**

I refer to the scheme of arrangement between Asciano and certain of its shareholders pursuant to which Australian Logistics Acquisition Investments Pty Limited will acquire all of the shares in Asciano held by those shareholders.

On 3 June 2016, the proposed scheme was approved by the requisite majority of shareholders. The results of the scheme meeting were announced on the ASX that day.

On 28 July 2016, the Supreme Court of New South Wales approved the scheme. The orders of the Court made under section 411(4)(b) of the Corporations Act 2001 (Cth) became effective today following their lodgment with ASIC.

The Court orders have also been lodged with ASX pursuant to ASX Listing Rule 7.19.3.

By this letter, and in accordance with ASX Listing Rule 17.2, Asciano requests that its shares be suspended from quotation from the close of trading today.

Asciano further requests that such suspension continue pending payment of the scheme consideration on the implementation date (19 August 2016), which is to be followed by delisting shortly afterwards.

Asciano is not aware of any reason why its shares should not be suspended.
