On 14 April 2016, BGD Corporation Ltd (ACN 009 074 588) (**BGD**, or the **Company**) announced the appointment of Chief Executive Officer Justin Walter.

Mr Walter is entitled to the issue of 2 million options as the Long Term Incentive (LTI) component of his remuneration package, which was detailed in the announcement of 14 April. Mr Walter has elected to immediately exercise 1,000,000 of those options, at an exercise price of \$0.042 per option (a 20% premium to the closing price of BGD shares yesterday).

Accordingly, attached for release is an Appendix 3B New Issue Announcement pertaining to the issue of 1,000,000 new shares and 1,000,000 options.
