THE COURT ORDERS THAT:

- (together, the SubZero Companies) required to be held pursuant to section 439A of the Corporations Act 2001 (Cth) (the Act) be extended to midnight on 9 November 2016.
- 3. Pursuant to section 447A(1) of the Act, Part 5.3A of the Act is to operate with respect to each of the SubZero Companies such that the meeting of creditors required by section 439A(1) of the Act may be held at any time during, or within five business days after the end of, the convening period as extended by order 2 above notwithstanding the provisions of s 439A(2) of the Act.
- 4. The Administrators of the SubZero Companies must, within 2 business days of the making of these orders, cause these orders to be:
- (a) published on any website maintained by the Administrators in respect of the administrations of the SubZero Companies; and
- (b) emailed to creditors of the SubZero Companies.
- 5. Any person, including any creditor of the SubZero Companies and the Australian Securities & Investments Commission, who can demonstrate sufficient interest have liberty to apply on 3 days' notice to vary or discharge these orders.
- 6. The Plaintiffs have liberty to apply to the Court for further extensions of the convening periods of the SubZero Companies at any time prior to 9 November 2016.
- 7. The Plaintiffs' costs of this proceeding be paid pro rata as a cost of the administration of each of the SubZero Companies.
