RosterCloud acquisition finalised

- Rision has finalised the acquisition of RosterCloud, a leading cloud based provider of rostering software for the catering industry
- The acquisition positions Rision as leader in the provision of rostering services to the catering and events industry, and significantly boosts its customer database

Rision Limited (ASX:RNL) ("Rision"), the team planning and analytics platform, is pleased to announce that it has finalised the acquisition of the RosterCloud business ("RosterCloud") in accordance with the previous ASX announcement dated 4 July 2016. In partial consideration of the acquisition, Rision has today issued 4,000,000 shares to the vendors (escrowed by written agreement with the vendors for a period of 12 months from today).

About RosterCloud

Founded in 2011, RosterCloud's web-technology includes a rostering system, event management, reporting and payroll services.

The company's client base includes elite catering and events companies: The Big Group and Damn Fine Foods, and the National Gallery of Australia amongst other businesses.

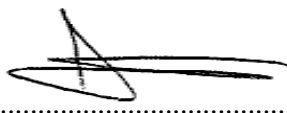
