SHORTFALL ISSUE - NON-RENOUNCEABLE ENTITLEMENT ISSUE

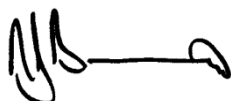
Australian Vanadium Limited ("Company") is pleased to advise that it has placed a further 100,779,901 ordinary fully paid shares (**Shares**) and 100,779,901 options exercisable at \$0.02 on or before 31 December 2018 (**Options**) pursuant to the non-renounceable entitlement issue offer dated 9 March 2016. The issue of Shares and Options forms part of the shortfall from the entitlement issue and raised a further \$1,310,138 to bring the total raising to \$3,014,498.

In accordance with the ASX Listing Rules, the Shortfall Shares and Options were issued on the same terms as the Shares and Options issued under the entitlement issue.

The directors are very pleased with the outcome of the issue and have resolved to close the issue.
