### **COMPLETION OF ACQUISITION OF SKY AND SPACE GLOBAL (UK) LIMITED**

Sky and Space Global Ltd (ACN 117 770 475) (formerly Burlison Energy Limited (**Company**)) is pleased to advise that the Company has completed the acquisition of 100% of the issued shares of Sky and Space Global (UK) Limited (**Acquisition**).

In accordance with the previously announced Heads of Agreement (and in accordance with Shareholder approvals obtained on 1 April 2016) the Company has issued:

- 228,716,185 fully paid ordinary shares (**Shares**) to investors pursuant to the Offer under the Company's replacement prospectus dated 4 April 2016 (**Prospectus**);
- 740,000,000 Shares and 300,000,000 Performance Shares (consisting of 100,000,000 Class A Performance Shares, 100,000,000 Class B Performance Shares and 100,000,00 Class C Performance Shares) amongst the Sky and Space Global UK) Limited shareholders (or their nominees); and
- 40,000,000 Shares to parties who assisted in facilitating the Acquisition.

#### **Board changes**

At completion of the Acquisition, Meir Moalem, Maya Glickman-Pariente, Yonatan Shrama and Brett Mitchell were appointed as directors of the Company. They join current director Peter Wall who remains on the Board.

Michael Sandy and Alexander Sundich have resigned as directors of the Company.

#### **Change of company name**

The Company has also changed its name from Burlison Energy Limited to Sky and Space Global Ltd and upon being readmitted to quotation on the ASX its shares will trade under the ASX ticker code "SSG".

The Company expects to complete its re-compliance with Chapters 1 and 2 of the ASX Listing Rules and for reinstatement of trading of its shares on the ASX to occur in the coming weeks.
