DIRECTIONS

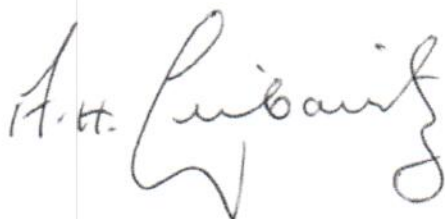
