The Board of Directors are pleased to announce that the acquisition of entire issued share capital of Polygoal Capital Limited (the "Acquisition") has completed today. Pursuant to the Agreement for the Sales & Purchase of the entire issued share capital of Polygoal Capital Limited entered between the vendors of Polygoal Capital Limited (the "Vendors") and the Company dated 22 January 2016 (the "S&P Agreement"), the Company has settled the Consideration of purchase by allotment and issue of 9,000,000 ordinary shares to the Vendors; and the Vendors have effected transfer of all the issued shares of Polygoal Capital Limited to Viagold Mining Group Limited, a wholly-owned subsidiary of the Company, as per the S&P Agreement.

The Acquisition has received all necessary regulatory and shareholder approvals as per result ASX announcement of SGM on 29 April 2016.
