### **Rision develops unique time and attendance technology**

---

- Rision has developed a unique, secure time and attendance tool that allows employers to track hours worked using the Rision mobile app
- A patent covering proprietary elements of the technology is being explored
- The tool is expected to accelerate sales in industries with mobile workforces including catering, cleaning and security

Rision Limited (ASX:RNL) ("Rision"), the team planning and analytics platform, is pleased to announce that it has developed a new, secure time and attendance tool called 'ClockOn' to allow staff to clock on and off from work using their mobile phone.

Time and attendance tools are critical to many businesses employing shift workers that need to accurately track the hours staff work. Today, a variety of tools are employed ranging from add-ons to point of sales software where employees are required to key in a code when they start work, to expensive biometric tools.

Rision Chief Technology Officer, Mr Bartek Mayshak said: "ClockOn enhances Rision's suite of mobile human resources solutions, and enables employees to use their mobile phones to register start and end times of work. It has been specifically designed to offer a low cost solution to existing competing technologies."

Rision Managing Director Dr Kate Cornick said: "This new tool has the potential to accelerate sales of Rision products to businesses where staff work at remote and disparate locations, including in events, facilities management and healthcare. Our catering clients are particularly interested in this technology to replace paper time sheets, reducing the amount of data entry required by office staff, and saving both time and money."

The development cost for the first phase of the clock on system is approximately USD\$35k, and beta trials of the technology are expected to begin in August.

Rision has commissioned Griffith Hack to support the filing a provisional patent for proprietary algorithms associated with the ClockOn system, before beta trials begin. This would be the second patent filed by the company, and the first to be developed since its relisting on the ASX.

The existing patent that has been accepted in Australia and New Zealand (as declared in the company's Prospectus) was developed by Rision Founder Mr Day. Regrettably the United States Patent Application No. 11/817,024 (also declared in the Prospectus) has been rejected following multiple unsuccessful appeals.
