1. INTRODUCTION

Mr Weston advised creditors that an audio recording of the meeting was being made and obtained creditors permission of same.

Mr Weston advised that the meeting had been convened in accordance with Section 436E of the Corporations Act, the Notice of Meeting dated 23 March 2016 and as advertised on ASiC Insolvency Notices Website on 24 March 2016.

2. CHAIRMAN

Mr Weston advised that no resolution was required to elect a Chairperson as the Administrator was to be Chairperson of the meeting pursuant to Corporations Regulation 5.6.17.

3. ATTENDANCE REGISTER, PROXIES & PARTICULARS OF DEBT

The Chairperson tabled the attendance register and proxies, and ensured that all those present had signed the attendance register. Refer to the attached.

The Chairperson advised that pursuant to Corporations Regulation 5.6.23 only creditors attending in person or those persons holding valid proxies from creditors were entitled to vote and then only if particulars of debt have been lodged.

4. QUORUM

The Chairperson declared that as two or more creditors were present in person or by proxy there was a quorum.

5. TIME AND PLACE OF MEETING

The Chairperson declared that pursuant to Corporations Regulation 5.6.14 the meeting had been validly convened and held at a time and place convenient to the majority of creditors entitled to receive notice.
