TRANCHE 1 OF PLACEMENT COMPLETED

Bannerman Resources Limited (ASX: BMN; NSX: BMN) (**Bannerman** or the **Company**) is pleased to advise that subsequent to the announcement on 28 October 2016, the Company has now issued 116,666,666 fully paid ordinary shares (**Placement**) at an issue price of A\$0.03.

A total of 101,020,918 shares were issued under the Company's 15% placement capacity under ASX Listing Rule 7.1 and a total of 15,645,748 shares were issued under the Company's additional 10% placement capacity pursuant to ASX Listing Rule 7.1A.

The remaining 16,666,667 new shares to Resource Capital Fund VI L.P. is subject to shareholder approval to be sought at an Extraordinary General Meeting to be held as early as practical.

Funds raised from the Placement, together with existing cash reserves, will be primarily used for internal and external engineering designed to assess and quantify opportunities to reduce Etango project operating and capital cost estimates that have arisen from the Company's successful Heap Leach Demonstration Program, and for general working capital.
