## **Empired to Provide 'Cohesion' Enterprise Content Management Service to the Department of Internal Affairs in New Zealand**

- Empired's wholly owned New Zealand subsidiary, Interger Limited, is one of three suppliers on the All-of-Government Enterprise Content Management services panel, which is also managed by the Department of Internal Affairs (DIA).
