## **SCHEME OF ARRANGEMENT - TIMETABLE UPDATE**

Asciano Limited (ASX: AIO, OTCUS: AIOYY) ("**Asciano**") today announces that the Supreme Court of New South Wales has adjourned the Second Court Hearing to consider the approval of the previously announced Scheme of Arrangement ("**Scheme**"). The Second Court Hearing is now scheduled for 10.00am on Thursday, 28 July 2016.

This adjournment follows the release last week of the Statement of Issues by the Australian Competition and Consumer Commission ("ACCC"). The proposed date for announcement of the ACCC's final informal review decision is expected to be Thursday, 21 July 2016.

The Scheme Meeting will take place as scheduled this Friday, 3 June 2016 in the Adelaide Room, Level 4, The Sofitel Sydney Wentworth, 61-101 Phillip Street, Sydney, commencing at 10.00am. All Asciano shareholders are encouraged to vote either by attending the Scheme Meeting in person or by lodging a proxy vote by 10.00am this Wednesday, 1 June 2016. Details of how to lodge a proxy vote are included on the Proxy Form and in the Scheme Booklet.

Asciano's Board of Directors continues to unanimously recommend that Asciano shareholders vote in favour of the Scheme, in the absence of a superior proposal.

The indicative key dates for the Scheme have accordingly been updated as set out below.
