Quarterly Activities Report for the period ending 31 March 2016

ACQUISITION OF IODM PTY LTD

Paradigm Metals Limited ("the Company") announced, in the December quarter, the acquisition of IODM Pty Ltd ("IODM"), an established and rapidly growing Financial Technology business.

Refer to announcements dated 29 December 2015 and 29 January 2016.

During the quarter, on 11 February 2016, the Company announced that IODM had signed a Heads of Agreement to form a strategic partnership with the Institute of Public Accountants ("IPA") for the distribution of the IODM Debt Management System to IPA members.

Under the agreement the IPA will promote the IODM System to its members as a value add proposition for their businesses. Subscription to the IODM System will be at the discretion of its members.

The Company announced on 3 March 2016 that IODM had collaborated with Big Four accounting firm PwC to integrate its automated accounts receivable software with PwC's innovative new cloud platform, PwC's Next.

Subsequent to quarter end, on 6 April 2016, the Company announced that IODM is working with National Australia Bank ("NAB") to integrate its automated accounts receivable management application with the bank's new Business In One digital platform for small business customers.

In accordance with the Notice of Meeting lodged 24 February 2016 and amended on 14 March 2016, all resolutions to give effect to the proposed transaction were approved by Shareholders on 29 March 2016.

On 8 March 2016, Mr Anthony Reilly resigned as Director and CEO of the Company and Mr Earle Harper was appointed as Non-Executive Director.
