Total cash and cash equivalents held by Simavita at the end of June 2016 was \$6,172,897

During the June quarter, the Company successfully raised \$7,353,000 as a result of significant support from its shareholders. The Company has also undergone a cost reduction program during the last quarter which has resulted in a 40% reduction in cash spend per month.

Cash receipts from customers for the quarter were up for the quarter to \$270,045 (last quarter 2015 \$141,246). Total cash receipts from sales for the full 2016 financial year to \$847,753. This figure represents an increase of 21% over the total cash receipts from customers for the corresponding 12 months in 2015 of \$701,743.
