RESIGNATION OF DIRECTOR

We advise that Mr Andrew Simpson has resigned as Non-Executive Chairman of India Resources Limited with effect from 7 October 2016 in order to focus on his other business interests.

The Board acknowledged the significant contribution made by Mr Simpson during his tenure as a director since August 2006.

The appointment of a replacement director is underway and a further announcement will be made as when this has been completed.

Attached is an Appendix 3Z, Final directors interest notice, on behalf of Mr Simpson. Lodgement of the notice has been delayed pending clarification with ASX of the reinstatement of trading in the Company's shares.
