SECONDARY TRADING NOTICE

Further to the Appendix 3B released on 19 April 2016, 37,360,000 Shares were issued at an issue price of \$0.032 to professional and sophisticated investors participating in the Placement.

Secondary Trading Notice Pursuant to Paragraph 708A(5)(e) of the Corporations Act 2001 ("Act")

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

 - B. the rights and liabilities attaching to the relevant Shares.
