# BlackWall Property Trust Rights Issue and Private Placement

On 19 October 2016, BlackWall Fund Services Limited as responsible entity for Blackwall Property Trust (ASX: BWR) (**BWR**) announced a capital raising to raise approximately \$12 million by way of:

- a private placement of 6.7 million ordinary units to sophisticated investors at \$1.20 per unit (\$8 million); and
- a 1:17 non-renounceable rights issue to existing unitholders at \$1.20 per new BWR unit (\$4 million).

The offers are not underwritten.

## Other information regarding the Rights Issue

Fractional entitlements to new units will be rounded to the nearest whole number of units. Holdings on different registers or sub-registers will not be aggregated for the purpose of calculating entitlements under the Rights Issue. New units issued under the Rights Issue will have the same entitlements to distributions as all units currently on issue. The new BWR units will rank equally with existing units in all respects.

## Other information regarding the Private Placement

The Trust will undertake a private placement of up to 6.7 million ordinary units at \$1.20 each to sophisticated investors only. No meetings are required to be held as the Trust has capacity within its 15% placement capacity and additional 10% placement capacity. The units issued will rank equally with all other ordinary units on issue.
