Digimatic Starts New Collaboration in Hong Kong

- DMC executes first agreement in Hong Kong SAR China

Potential JVC Collaboration with Hong Kong ASC Ltd

The collaboration between ASC and Digimatic Solutions will potentially allow ASC to create a new revenue stream for its own business as well as its merchants, by reaching out directly to end users and helping its local merchants to reach out to the regional market.

With their already strong fashion ERP system in place, ASC can also integrate brands seamlessly across to the new eCommerce platform without having to set up a completely new system for the brand owners to use. This will be more cost-effective and also save the brands time and effort in setting up their eStores.

From the partnership, Digimatic Solutions will be able to increase its market presence to the Hong Kong and China regions, and at the same time increase its revenue and profits through the JVC agreement. With strong technological capabilities, Digimatic Solutions is able to help the brands increase their reach from a single market to worldwide markets by populating their products to other marketplaces like Lazada and eBay.
