# **3Q16 METRICS – SALES OF OCCUPATION RIGHTS**

Summerset Group achieved 196 sales for the quarter ending 30 September 2016, comprising 125 new sales and 71 resales.

Summerset CEO Julian Cook said total sales for the quarter were the highest ever achieved across the group.

"Sales in the third quarter were 21% higher than the same period last year. New sales reached a high for the group with 125 sales achieved across the last three months.

"The past nine months has seen good growth for Summerset and strong demand for our offering. Wigram village's main building in Christchurch opened in September, contributing to strong third quarter sales," said Mr Cook.

Resales for the quarter were also strong at 71, resulting in only 21 unsold resale stock at 30 September.

The first residents at the Ellerslie village in Auckland will move in during October, Summerset's 21st retirement village in New Zealand.
