RIGHTS ISSUE UPDATE

On behalf of the Board, CuDeco Limited advise that the sub-underwriters to the Rights Issue have subscribed for 25,119,947 ordinary shares under the Underwriting Agreement, which were allotted by the Company on 24 May 2016.

The remaining commitment under the Underwriting Agreement for 12.5 Million shares is expected to be allotted by 31 July 2016.
