

### AUSTRALIA'S 1st COMMERCIAL SUPER FAST CHARGING STATION TO BEGIN LPE'S LONG RANGE EV NETWORK

- Australia's first commercial electric vehicle (EV) charging station with fast charge capabilities deployed by LPE
- The charging station is the most technologically-advanced fast charger available
- Charging will be cheaper on a km-to-km basis than for a combustion engine, consumers will pay for the exact amount of electricity used (kWh).

**Locality Planning Energy Holdings Limited** (ASX: LPE) (the Company) - Energy Retailer Locality Planning Energy (ASX: LPE) is pleased to announce the deployment of the first super-fast, commercial electric vehicle (EV) charging stations in Australia. The charging station is one of five set to be deployed across Southeast Queensland and will enable drivers to charge EVs 25 times faster and are cheaper than standard chargers.

This is a significant part of the Company's growth strategy and is going to be a major contributing factor on how LPE will value add and continue to support strata community's energy needs.

Developed and manufactured by Brisbane-based [Tritium](#), the charging station is the world's most technologically-advanced 50 kW DC fast charger for EVs, capable of adding 50km range to an EV battery charge in just 10 minutes. By comparison, this charge would take over six hours using a traditional wall socket.

Utilising LPE's embedded energy networks, the charging station will also be the first commercial station in Australia to provide electricity to an EV at a rate cheaper on a km-to-km basis. Drivers will pay for the exact amount of electricity used to recharge their vehicles (kWh), making it just as cost effective as home charging.

**Damien Glanville, Director and Chief Executive Officer, LPE states;** "The charging station marks an exciting development for electric vehicles owners and we are thrilled to combine the power of Tritium's cutting-edge and award winning technology with our embedded electricity network to make charging faster, easier and more cost effective than ever before."

The charging station, which has been installed at the [Noosa Blue Resort](#) in Noosa Heads, is the first of five sites earmarked for EV charging station deployment in Southeast Queensland.

"With advanced infrastructure that makes EV charging more convenient and accessible, we hope to accelerate the adoption of EVs across Australia and enable greater flexibility for drivers. EV trips between Noosa and Brisbane are now possible and trips to further destinations will soon be a reality," added Mr. Glanville.

A dedicated mobile app will allow drivers to check the charging station's availability, reserve a charging space and monitor their car's charging progress.

**Paul Sernia, Commercial Director, Tritium said:** "Facilitating an advanced charging infrastructure is key to accelerating the adoption of EVs, both domestically and overseas. We have seen growing demand for EVs around the world and as the only Australian company to design and manufacture EV charging stations locally, we look forward to demonstrating how the technology can enable more sustainable and cost effective transport."
