TikForce to generate immediate revenue through agreement with leading HR company Davidson Group

Highlights

- Tikforce signs binding Heads of Agreement with one of the leading national HR providers, Davidson Group;
- Davidson will pay TikForce \$0.50 per user facial recognition identity check;

TikForce Limited (ASX: 'TKF' or the 'Company') is pleased to announce that it has signed a binding Heads of Agreement (HOA) with Davidson Group (Aust) Pty Ltd that will give Davidson Group the ability to quickly verify user identities using TikForce's platform.

Under the agreement, TikForce will provide Application Program Interfaces (APIs) to allow Davidson Group's system to automatically connect to the TikForce platform to perform real-time identity verification of users taking an online assessment.

Davidson Group has over 300 courses in its library and will pay TikForce \$0.50 for every user taking an online test who it verifies through the TikForce platform. Davidson Group will also pay a nominal monthly fee to TikForce to cover the cost of maintaining the verification service.

Further, the agreement allows the Company to resell Davidson Group's courses with TikForce, earning the Company between \$20 -\$100 for each course sold.
