NEPEAN SOUTH PROJECT

Fieldwork Commences




Figure 1: Project location

Alliance Resources Limited (Alliance) is pleased to announce the commencement of exploration activities at its Nepean South nickel-coppergold Project (Project) in Western Australia's Eastern Goldfields (Figure 1).

The Project is located 26 km southwest of Coolgardie and captures approximately 14 km strike length of ultramafics interpreted to be the southern extension of the sequence hosting the Nepean Nickel Mine (historic production: 1.1 Mt @ 3.0 % Ni for 32,200 t Ni metal).




Figure 2: Nepean South, showing priority exploration target area and orientation soil survey lines on background aeromagnetic image.

Following a detailed literature review of the existing geological data Alliance has determined that the area immediately to the south of the Nepean Mine is the highest priority target within the Project and is prospective for both komatilitic-hosted nickel sulphide deposits and greenstone-hosted orogenic gold deposits (Figure 2).

Alliance has commenced a 156 sample orientation auger soil survey on three 400 metre spaced lines in areas of interpreted shallow transported cover. The objective of this orientation survey is to determine the effectiveness of using auger soil sampling as an exploration tool within the target area. Auger soil samples have been collected at 50 metre spaced intervals across areas of known ultramafic rock and will be analysed for gold and base metals.

The results of this orientation survey are expected in the coming weeks and, if successful, will lead into several phases of extensional and infill auger soil

sampling between now and year end with the objective of defining target areas for drill testing in early 2017.

If the orientation auger soil survey is unsuccessful, Alliance will continue exploration of this priority target area by using a combination of electromagnetic surveys and RAB and/or aircore drilling.
