Explanatory Memorandum

1. Introduction

This Explanatory Memorandum is provided to shareholders of **Byte Power Group Limited** ABN 80 009 268 571 (**Company**) to explain the Resolutions to be put to Shareholders at the Annual General Meeting to be held at HWL Ebsworth Lawyers, Level 19, 480 Queen Street, Brisbane, on Wednesday 30 November 2016 at 3:00 pm (Brisbane time).

The Directors recommend Shareholders read the accompanying Notice of Meeting and this Explanatory Memorandum in full before making any decision in relation to the Resolutions.

Terms used in this Explanatory Memorandum are defined in Section 8.

The Notice of Meeting sets out the details of four (4) separate resolutions to be put to Shareholders comprising the following:

2. Consider the company's annual report

The Company's Annual Report comprising the Directors' Report and Auditors' Report, Directors' Declaration, Statement of Financial Performance, Statement of Financial Position, Statement of Cashflows and notes to and forming part of the accounts for the Company for the financial year ended 30 June 2016 were released to the ASX Limited on 3 October 2016. The Company's Annual Report is placed before the Shareholders for discussion. No voting is required for this item.

3. Resolution 1 - Remuneration report

The Board has submitted its Remuneration Report to Shareholders for consideration and adoption by way of a non-binding advisory resolution.

The Remuneration Report is set out in the Directors' Report section of the Annual Report. The Remuneration Report:

- explains the Board's policy for determining the nature and amount of remuneration of executive directors and senior executives of the Company;
- explains the relationship between the Board's remuneration policy and the Company's performance;
- sets out remuneration details for each Director and the most highly remunerated senior executives of the Company; and
- details and explains any performance conditions applicable to the remuneration of executive directors and senior executives of the Company.

A reasonable opportunity will be provided for discussion of the Remuneration Report at the meeting.

The Board unanimously recommends that Shareholders vote in favour of adopting the Remuneration Report. A vote on this resolution is advisory only and does not bind the Directors of the Company.

Voting restrictions on Key Management Personnel and their proxies and Closely Related Parties

Members of the Key Management Personnel and their proxies and Closely Related Parties are restricted from voting on a resolution (**Voting Restriction**) put to Shareholders that the Remuneration Report of the Company be adopted. Key Management Personnel are those persons having authority and responsibility for planning, directing and controlling the activities of the entity, directly or indirectly, including any director (whether executive or otherwise) of that entity.

The Voting Restriction does not apply where:



- (a) the chairperson or any other member of the Key Management Personnel is appointed in writing (by a Shareholder who is not a member of the Key Management Personnel or a Closely Related Party of Key Management Personnel) as a proxy (Management Proxy) with specific instructions on how to vote on a resolution to adopt the Remuneration Report of the Company; or
- (b) the chairperson is appointed in writing (by a Shareholder who is not Key Management Personnel or a Closely Related Party of Key Management Personnel) as a proxy with no specific instructions on how to vote on a resolution to adopt the Remuneration Report of the Company, where the Shareholder provides express authorisation for the chairperson to vote on the resolution.

Shareholders should be aware that any undirected proxies given to the Chairperson will be cast by the Chairperson and counted in favour of the resolutions the subject of this Meeting, including this Resolution 1, subject to compliance with the Corporations Act.

4. Resolution 2 - Ratification of the issue of Shares to Eurasian Capital, LLC.

4.1 Introduction

On 21 September 2016 the Company entered into a contract with Eurasian Capital, LLC. for the purposes of Eurasian Capital to provide Institutional Funding / Public Relations services (non-exclusive) on a month by month basis. Under the terms of the Contract, the Company was to pay \$5,000 per month (based on an issue price of not less than AUD\$0.002 per share) of engagement to Eurasian Capital for its services.

4.2 Resolution 2

Resolution 2 seeks the ratification of shareholders for the previous issue of 2,500,000 fully paid ordinary shares (**Eurasian Capital Shares**) Shares at AUD\$0.002 per Share to Eurasian Capital.

4.3 ASX Listing Rule 7.4

ASX Listing Rule 7.4 provides that an issue of securities made without prior approval under ASX Listing Rule 7.1 can be treated as having been made with that approval if shareholders subsequently approve it.

In accordance with ASX Listing Rule 7.4, shareholder approval is sought to ratify the issue of Previous Shares in the Company, being issues of securities made by the Company during the previous 12 months for which shareholder approval has not already been obtained.

As previously outlined, ASX Listing Rule 7.1 prohibits a company, except in certain cases, from issuing new shares equivalent in number to more than 15% of its capital in any 12 month period without the prior approval of its shareholders. Securities issued with shareholder approval under ASX Listing Rule 7.1 do not count towards the 15% limit.

If this Resolution 2 is approved it will have the effect of refreshing the Company's ability to issue up to a further 15% of its capital during the next 12 months without the need to obtain further shareholder approval.

For the purposes of ASX Listing Rule 7.5, the Company advises:

- the number of shares issued to Eurasian Capital was 2.500,000 fully paid ordinary shares;
- the Eurasian Capital Shares were issued and allotted on 28 September 2016;
- the Eurasian Capital Shares were issued at AUD\$0.002 per Share;
- the Eurasian Capital Shares were issued to Eurasian Capital, LLC. who falls within one or more of
 the classes of exemptions specified in Section 708 of the Corporations Act, and is not a related
 party of the Company (within the meaning of the Corporations Act and the Listing Rules;.



- the Eurasian Capital Shares have the same rights and entitlements as all other fully paid ordinary shares in the issued capital of the Company; and
- the Eurasian Capital Shares were issued in satisfaction of the Company's obligation to pay Eurasian Capital for one month of Institutional IR Services and accordingly no funds were raised on the issue of the Eurasian Capital Shares.

5. Resolution 3 – Approval of Converting Loan and the Issue of Shares to Tan Ming Da and Tan Hua Hoon upon Conversion

5.1 Introduction

On 17 April 2009 the Company entered into a converting loan agreement with Tan Ming Da (**Da**) and Tan Hua Hoon (**Hoon**). Under the converting loan agreement, the Company was provided with a loan in the amount of AUD\$216,000 with a maturity date of 23 April 2010 with the right to issue and allot shares subject to Shareholder approval. As the right to issue and allot shares under the converting loan agreement has since lapsed, a new converting loan agreement with Da and Hoon has been entered into as at 19 October 2016 (**Da and Hoon Agreement**).

The conditions of the Da and Hoon Agreement are:

- (a) new loan amount of AUD\$253,626.55 (**Da and Hoon Loan Amount**) consisting of the original loan amount of AUD\$216,000 plus accrued interests of AUD\$37,626.55;
- (b) the issue of Shares which are equivalent in value to the Loan Amount and have an issue price of AUD\$0.002 per Share, subject to Shareholder approval; or
- (c) by bank cheque or bank transfer to Da and Hoon for the Loan Amount.

Da and Hoon as the lender has the option to have the Loan Amount repaid through the issue of Shares and now seeks Shareholder approval for the issue of Shares under the Da and Hoon Agreement.

5.2 Resolution 3

Resolution 3 seeks Shareholder approval for the converting loan and the issue of 126,813,276 Shares on conversion of the converting loan to Da and Hoon (**Da and Hoon Shares**) in satisfaction of the obligation of the Company to repay the Da and Hoon Loan Amount if Da and Hoon elect to convert the Loan Amount to shares.

If the issue of the Da and Hoon Shares is not approved the Company will be required to repay the Da and Hoon Loan Amount on or before 19 October 2018.

5.3 Listing Rule 7.1

ASX Listing Rule 7.1 prohibits a company, except in certain cases, from issuing new shares equivalent in number to more than 15% of its capital in any 12 month period without the prior approval of its shareholders.

In accordance with Listing Rule 7.1 and the terms and conditions of the Da and Hoon Agreement the Company is now seeking the approval of Shareholders for the issue of the Da and Hoon Shares.

The effect of the Shareholders approving the issue of the Da and Hoon Shares will be that the issue will not be counted as part of the Company's 15% limit under ASX Listing Rule 7.1, and the Company will therefore retain a greater proportion of the 15% limit for any subsequent requirements that may arise.

In accordance with ASX Listing Rule 7.3, the Company advises as follows:

• the maximum number of Shares that will be issued under this Resolution 3 is 126,813,276 Shares;



- the equity securities, being the converting loan under the Da and Hoon Agreement will come into effect from the date of the AGM subject to the passing of Resolution 3. The Da and Hoon Shares will be issued and allotted no later than 19 October 2018;
- the issue price of the Da and Hoon Shares is AUD\$0.002 per Da and Hoon Share;
- conversion of the Da and Hoon Shares can only occur in minimum transactions of AU\$50,000 per tranche;
- the Da and Hoon Shares will be issued to Da and Hoon who fall within one or more of the classes of
 exemptions specified in Section 708 of the Corporations Act. The Company confirms that neither Da
 or Hoon are a related party of the Company (within the meaning of the Corporations Act and the
 Listing Rules);
- the Da and Hoon Shares will have the same rights and entitlements as all other fully paid ordinary shares in the issued capital of the Company;
- the Company will make application for quotation of the Da and Hoon Shares to be issued; and
- the Da and Hoon Loan Amount was used for general working capital and retiring existing debt.

6. Resolution 4 - Approval to issue an additional 10% of the issued capital of the Company over a 12 month period pursuant to Listing Rule 7.1A

6.1 Introduction

Pursuant to Resolution 4, the Company is seeking shareholder approval to issue an additional 10% of issued capital over a 12 month period pursuant to Listing Rule 7.1A. If passed, this Resolution will allow the Company to allot and issue up to the number of new Equity Securities calculated in accordance with Listing Rule 7.1A.2 (**Placement Securities**) each at an issue price of at least 75% of the volume weighted average price (**VWAP**) for the Company's Equity Securities in that class (calculated over the last 15 days on which trades in the Equity Securities are recorded immediately before the date on which the price at which the Placement Securities are to be issued is agreed, or if the Placement Securities are not issued within five trading days of that date, the date on which the Placement Securities are issued) (**Issue Price**).

This approval is sought pursuant to Listing Rule 7.1A which recently came into effect. Under Listing Rule 7.1A small and mid cap listed entities that meet the eligibility threshold and have obtained the approval of their ordinary shareholders by special resolution at the annual general meeting, are permitted to issue an additional 10% of issued capital over a 12 month period from the date of the annual general meeting (Additional 10% Placement). The Additional 10% Placement under Listing Rule 7.1A is in addition to the ability of the Company to issue 15% of its issued capital without shareholder approval over a 12 month period pursuant to Listing Rule 7.1. The Company may issue the Placement Securities to raise funds for the Company and as non-cash consideration (further details of which are set out below). Funds raised from the issue of Placement Securities, if undertaken, may be applied towards potential acquisition, supporting the development of the Company's current businesses, for the retirement of debt of the Company and for general working capital.

The Directors of the Company unanimously recommend that Shareholders vote in favour of Resolution 4.



(a) General

(1) Eligibility

An entity is eligible to undertake an Additional 10% Placement if at the time of its annual general meeting it has a market capitalisation of \$300 million or less and it is not included in the S&P/ASX300 Index (**Eligible Entity**).

For illustrative purposes only, on 18 October 2016, the Company's market capitalisation was \$2.2 million based on the closing trading price on that date. The calculation of market capitalisation will be based on the closing price of the shares, on the last trading day on which trades in the shares were recorded before the date of the AGM, multiplied by the number of shares on issue (excluding restricted securities and securities quoted on a deferred settlement basis).

The Company is also not included in the S&P/ASX300 Index as at the time of this AGM, however, it should be noted that the S&P/ASX300 Index is rebalanced twice a year in March and September.

The Company is therefore an Eligible Entity and able to undertake an Additional 10% Placement under Listing Rule 7.1A.

In the event that the Company for any reason ceases to be an Eligible Entity after the Company has already obtained shareholders' approval pursuant to this Resolution 4, the approval obtained will not lapse and the Company will still be entitled to issue the Placement Securities.

(2) Special Resolution

Listing Rule 7.1A requires this Resolution 4 to be passed as a Special Resolution, which means that it must be passed by at least 75% of the votes cast by members entitled to vote on the resolution. Pursuant to Listing Rule 7.1A, no Placement Securities will be issued until and unless this Special Resolution is passed at the meeting.

(3) Shareholder Approval

The ability to issue the Placement Securities is conditional upon the Company obtaining shareholder approval by way of a Special Resolution at the Meeting.

(b) 10% Placement Period - Listing Rule 7.1A.1

Assuming Resolution 4 is passed, shareholder approval of the Additional 10% Placement under Listing Rule 7.1A is valid from the date of the AGM and expires on the earlier to occur of:

- (1) the date that is 12 months after the date of the AGM; or
- the date of the approval by shareholders of a transaction under Listing Rule 11.1.2 (a significant change to the nature or scale of activities) or 11.2 (disposal of main undertaking).

or such longer period if allowed by ASX.

If approval is given for the issue of the Placement Securities then the approval will expire, on 30 November 2017. The approval will cease to be valid in the event that holders of the Company's ordinary securities approve a transaction under listing rule 11.1.2 or 11.2.



(c) Calculation for Additional 10% Placement - Listing Rule 7.1A.2

Listing Rule 7.1A.2 provides that Eligible Entities which have obtained shareholder approval at an annual general meeting may issue or agree to issue, during the 12 month period after the date of the annual general meeting, a number of Equity Securities calculated in accordance with the following formula:

(A x D) - E

Where:

A is the number of ordinary securities on issue 12 months before the date of issue or agreement:

- (1) plus the number of fully paid ordinary securities issued in the 12 months under an exception in Listing Rule 7.2;
- (2) plus the number of partly paid ordinary securities that became fully paid in the 12 months:
- (3) plus the number of fully paid ordinary securities issued in the 12 months with approval of holders of ordinary securities under Listing Rules 7.1 or 7.4 (but note that this does not include an issue of fully paid ordinary securities under the entity's 15% placement capacity without shareholder approval); and
- (4) less the number of fully paid ordinary securities cancelled in the 12 months.

D is 10 percent.

E is the number of Equity Securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the date of the issue or agreement to issue that are not issued with the approval of shareholders under Listing Rules 7.1 or 7.4.

(d) Listing Rule 7.1A.3

(1) Equity Securities

Any Equity Securities issued under the Additional 10% Placement must be in the same class as an existing quoted class of Equity Securities of the Company.

As at the date of this notice of meeting, the only class of Equity Securities in the Company quoted on the ASX are ordinary shares. The Company presently has 2,235,069,989 ordinary shares on issue at the date of this Notice of Meeting.

(2) Minimum Issue Price

The issue price for the Placement Securities issued under Listing Rule 7.1A must be not less than 75% of the VWAP of Equity Securities in the same class calculated over the 15 trading days immediately before:

- (A) the date on which the price at which the relevant Placement Securities are to be issued is agreed; or
- (B) if the relevant Placement Securities are not issued within five trading days of the date in paragraph (A) above, the date on which the relevant Placement Securities are issued.



(e) Information to be given to ASX - Listing Rule 7.1A.4

If Resolution 4 is passed and the Company issues any Placement Securities under Listing Rule 7.1A, the Company will give to ASX:

- (1) a list of allottees of the Placement Securities and the number of Placement Securities allotted to each (this list will not be released to the market); and
- (2) the following information required by rule 3.10.5A, which will be released to the market on the date of issue:
 - (A) details of the dilution to the existing holders of Equity Securities caused by the issue;
 - (B) where the Equity Securities are issued for cash consideration, a statement of the reasons why the Company issued the Equity Securities as a placement under rule 7.1A and not as (or in addition to) a pro rata issue or other type of issue in which existing shareholders would have been eligible to participate;
 - (C) details of any underwriting arrangements, including any fees payable to the underwriter; and
 - (D) any other fees or costs incurred in connection with the issue.

(f) Listing Rules 7.1 and 7.1A

The ability of an entity to issue Equity Securities under Listing Rule 7.1A is in addition to the entity's 15% placement capacity under Listing Rule 7.1.

At the date of this Notice of Meeting, the Company has on issue 2,235,069,989 Shares. The Company will have the capacity to issue the following Shares on the date of the Meeting:

- (1) 335,260,498 Shares under Listing Rule 7.1; and
- (2) subject to shareholder approval being obtained under Resolution 4, 223,506,999 Shares under Listing Rule 7.1A.

The actual number of Equity Securities that the Company will have the capacity to issue under Listing Rule 7.1A will be calculated at the date of issue of the Equity Securities in accordance with the formula prescribed in Listing Rule 7.1A.2 (as described above).

6.3 Specific Information required by Listing Rule 7.3A

(a) Minimum Price of securities issued under Listing Rule 7.1A - Listing Rule 7.3A.1

Pursuant to and in accordance with Listing Rule 7.1A.3, the Placement Securities issued pursuant to approval under Listing Rule 7.1A must have an issue price of not less than 75% of the VWAP for the Equity Securities over the 15 trading days immediately before:

- (1) the date on which the price at which the Placement Securities are to be issued is agreed; or
- (2) if the Placement Securities are not issued within five trading days of the date in paragraph (1) above, the date on which the Placement Securities are issued.

The Company will disclose to the ASX the issue price on the date of issue of the Placement Securities.

(b) Risk of economic and voting dilution - Listing Rule 7.3A.2



As provided by Listing Rule 7.3A.2, there is a risk of economic and voting dilution to the existing shareholders. The Company currently has on issue 2,235,069,989 Shares. The Company could issue 223,506,999 Shares on the date of the Meeting, however, it is important to note that the exact number of Equity Securities which may be issued will be calculated in accordance with the formula contained in Listing Rule 7.1A.2 details of which are set out above. Any issue of Placement Securities will have a dilutive effect on existing Shareholders.

There is a specific risk that:

- (1) the Market Price for the Company's Equity Securities may be significantly lower on the date of the issue of any Placement Securities than it is on the date of the Meeting; and
- (2) the Placement Securities may be issued at a price that is at a discount to the Market Price for the Company's Equity Securities on the issue date,

which may have an effect on the amount of funds raised by the issue or the value of the Placement Securities.

As required by Listing Rule 7.3A.2, Table 1 below shows the potential economic and voting dilution effect, in circumstances where the issued share capital has doubled and the Market Price of the shares has halved. Table 1 also shows additional scenarios in which the issued share capital has increased (by both 50% and 100%) and the Market Price of the shares has:

- decreased by 50%; and
- increased by 100%.

(a) Final date for issue - Listing Rule 7.3A.3

As required by Listing Rule 7.3A.3, the Company will only issue and allot the Placement Securities during the 12 months after the date of this Meeting which the Company anticipates will end on 30 November 2017.

However, this approval will cease to be valid in the event that holders of the eligible entity's ordinary securities approve a transaction under rule 11.1.2 or rule 11.2.

(b) Purpose - Listing Rule 7.3A.4

As noted above, the purpose for which the Placement Securities may be issued include to raise funds for the Company and as non-cash consideration (further details of which are set out below). Funds raised from the issue of Placement Securities, if undertaken, may be applied towards potential acquisitions, supporting the development of the Company's current businesses, for the retirement of debt of the Company and for general working capital.

(c) Shares Issued for Non-cash consideration - Listing Rule 7.3A.4

The Company may issue Placement Securities for non-cash consideration, such as the acquisition of new assets or investments or as consideration for services provided to the Company. The identity of the allottees of Placement Securities will be determined on a case-by-case basis having regard to a number of factors including but not limited to the following:

- (1) the methods of raising funds that are available to the Company including, but not limited to, rights issue or other issue in which existing shareholders can participate;
- (2) the effect of the issue of the Placement Securities on the control of the Company;
- (3) the financial situation and solvency of the Company; and
- (4) advice from corporate, financial and broking advisers (if applicable).

The allottees of the Placement Securities have not been determined as at the date of this Notice but may include existing substantial shareholders and new shareholders who are not related parties or associates of a related party of the Company.

Further, if the Company is successful in acquiring new assets or investments for which Placement Securities are issued as consideration, it is likely that the allottees of some of the Placement Securities will be the vendors of the new assets or investments.



(e) Shares Issued Since Last AGM

Since the 2015 AGM the Company has issued a total of 2,500,000 equity securities, representing 0.11% of the total number of equity securities on issue 12 months prior to the date of the 2016 AGM, details of which are as follows:

i. An issue on 28 September 2016 of 2,500,000 Shares to Eurasian Capital, LLC. The Shares were fully paid ordinary shares ranking equally with existing fully paid ordinary shares on issue. The issue price was AUD\$0.002 per Share. The Eurasian Capital Shares were issued in satisfaction of the Company's obligation to pay Eurasian Capital for one month of Institutional IR Services and accordingly no funds were raised on the issue of the Eurasian Capital Shares.

6.4 Voting Exclusion Statement

A voting exclusion statement is included in the notice of meeting. At the date of the notice of meeting, the proposed allottees of any Placement Securities are not as yet known or identified. In these circumstances (and in accordance with the note set out in Listing Rule 14.11.1 relating to Listing Rules 7.1 and 7.1A), for a person's vote to be excluded, it must be known that that person will participate in the proposed issue. Where it is not known who will participate in the proposed issue (as is the case in respect of the Placement Securities), shareholders must consider the proposal on the basis that they may or may not get a benefit and that it is possible that their holding will be diluted and there is no reason to exclude their votes.


