Scheme Booklet to be sent to Nuplex Shareholders

Today, Nuplex Industries Limited (NZX/ASX: NPX) is sending all Nuplex Shareholders a physical copy of the Scheme Booklet relating to the proposal from Allnex New Zealand Limited (Allnex) via the New Zealand postal service. This Scheme Booklet was previously lodged with the relevant exchanges on 13 June 2016.
