Summary of Unlisted Option Terms

1. The **Series A Options** have an exercise price of 25 cents and an expiry date of 31 December 2017. The Series A Options are primary Options which upon exercise of each Series A Option result in the issue of one Share and one Series B Option (a secondary Option). A Series B Option has an exercise price of 40 cents and an expiry date of 31 December 2020.
2. The **Series C Options** have an exercise price of 25 cents and an expiry date of 31 December 2018. They vest 6 months after the Company is admitted to the Official List (31 May 2016) provided the holder has continued to be engaged as an employee, contractor, consultant or Board member prior to the vesting date.
3. The **Series D Options** have an exercise price of 40 cents and an expiry date of 31 December 2019. They vest 18 months after the Company is admitted to the Official List (31 May 2017) provided the holder has continued to be engaged as an employee, contractor, consultant or Board member prior to the vesting date.
4. The **Series E Options** have the same terms as the Listed Options (HZRO) with an exercise price of 30 cents and an expiry date of 31 December 2018. 300,000 Series E Options vest 6 months after issue (18 September 2016) provided the holder has continued to be engaged as an employee, contractor, consultant or Board member prior to the vesting date.
5. The **Series F Options** have an exercise price of 55 cents and an expiry date of 30 June 2019. They vest 6 months after appointment provided the holder has continued to be engaged as an employee, contractor, consultant or Board member prior to the vesting date.
6. The **Series G Options** have an exercise price of 75 cents and an expiry date of 30 June 2020. They vest 18 months after appointment provided the holder has continued to be engaged as an employee, contractor, consultant or Board member prior to the vesting date.
