Funds Under Management, Administration, Advice and Supervision (FUMAS) for the 3 month period to 30 September 2016

IOOF Holdings Ltd (IOOF) has achieved positive net flows of \$833 million in funds under management, administration and advice (FUMA) for the first quarter of the 2017 financial year. Total FUMA as at 30 September 2016 totalled \$107.1 billion. Funds under supervision were \$31.0 billion.

Net positive flows into IOOF's Advice businesses of \$327 million for the quarter included strong inflows from our aligned adviser groups.

Investment Management flows of \$355 million for the quarter included strong flows from flagship platforms and Shadforths into IOOF's investment business. Flows in this segment also benefited from funds re-allocation post the platform rationalisation completed in June 2016.

Total platform net flows were \$151 million for the quarter. Organic growth momentum within IOOF's flagship platforms continued with a quarterly net inflow of \$149 million.

IOOF Managing Director, Christopher Kelaher, commented, "It is very pleasing that we continue to achieve positive net flows across all segments of our business. Our advice and flagship platform businesses have demonstrated another quarter of sustained organic growth. 
