# **CORPORATE GOVERNANCE STATEMENT 2016**

## INTRODUCTION

Sovereign Metals Limited (**Sovereign** or **Company**) and the entities it controls believe corporate governance is a critical pillar on which business objectives and, in turn, shareholder value must be built.

The Board has adopted a suite of charters and key corporate governance documents which articulate the policies and procedures followed by Sovereign.

These documents are reviewed at least annually to address any changes in governance practices and the law.
