Highlights

Continuing operations


- > Sales up 338% to \$15.4 million
- > FY loss \$1.5 million reduced from \$2.2 million (FY15)
- Stronger 2H delivers EBITDA \$200K resulting in \$1.4 million turnaround from 1H
- > FY order intake \$17.6 million
- ➤ Work in hand increased from \$500K to \$3.8 million 30 June.
- Won Simonds Stadium and Melbourne Airport AV projects combined \$3 million
- Work in hand August 2016 \$10 million following major project wins
- Acquired AV & IT distributor Dueltek Distribution
- Appointed Australian distributor of AT&T structured data cabling products
- Won multiple major lighting projects with blue chip clients
- > Strong R&D focus delivers first sales of "Ascendancy" control system.

- > Sale of appliance parts division for \$5 million
- Closure and exit of manufacturing division
- Profit from discontinued operations \$1.5 million
