Re – Notice of change of interest of substantial holder – Sugar Terminals Limited

Please find enclosed a form 604 – Notice of change of interests of substantial holder, lodged by MSF Sugar Pty Ltd ACN 009 658 708 ("MSF Sugar") on behalf of MP Australia Investments Pty Ltd ("MPAI"), MP Australia Holdings Pty Ltd ("MPAH"), Mitr Phol Sugar Corp. Ltd ("Mitr Phol") and the Vongkusolkit family who owns 100% shares in Mitr Phol through Mid-Siam Sugar Co. Ltd ("Vongkusolkit Family"), in relation to a change of relevant interest in Sugar Terminals Limited ACN 084 057 601 ("STL").

Reconciliation of previous filings

As notified to the NSX on 3 February 2016, MPAI acquired 3,626,322 G Class shares increasing its voting power from 0.21% to 1.21%.

It was also notified that Mitr Siam Pte Ltd had transferred all of its shares in MSF Sugar to MPAI and therefore no longer held any shares in STL.

Since the last update

MPAI has transferred all of its shares in MSF Sugar to MPAH and therefore no longer holds any M Class shares in STL.

MPAI has purchased a further 3,615,819 shares through a series of on-market transfers and one off-market transfer which has resulted in its shareholdings in G-Class shares increasing from 4,368,316 to 7,984,135 and its voting power increasing from 1.21% to 2.22%.
