1. Resolution 1

THAT for the purpose of Article 20.1(a) of the Articles of Association, the payment of directors' fees of a notional amount of A\$12,000 (Australian Dollars Three Thousand Only) for the financial year ended 31 March 2018 be and is hereby approved.

2. Resolution 2

THAT WANG Caifu who is seeking re-election under Article 18.5 of the Articles of Association be and is hereby re-elected as a director of the Company.

3. Resolution 3

THAT HE Ping who is seeking re-election under Article 18.5 of the Articles of Association be and is hereby re-elected as a director of the Company.

4. Resolution 4

THAT SHANG Zonggen who is seeking re-election under Article 18.5 of the Articles of Association be and is hereby re-elected as a director of the Company.

5. Resolution 5

THAT J.K. Tan & Co., Chartered Accountants be and is hereby re-appointed as auditors of the Company AND THAT directors of the Company be and are hereby authorised to fix their remuneration.



## **VOTING EXCLUSION**

The Company will disregard any votes cast in favour of Resolution 1, by the Chairman, any director of the Company and their associates. However, the Company will not disregard a vote if it is cast by an above-mentioned person:

- (a) who votes in accordance with the directions on the proxy form, or
- (b) if it is cast by that person chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

2. Resolution 1

Article 20.1(a) of the Articles of Association requires that directors' fees be determined by the Company in general meeting. If this resolution is approved, the directors propose that the amount of directors' fees approved by shareholders be paid to each director as follows:

3. Resolution 2

Article 18.5 of the Articles of Association provides, inter alia, that a director who is appointed a director by other directors, either to fill a casual vacancy or as an additional director, holds office only until the next following annual general meeting and shall be eligible to seek re-election.

WANG Caifu was appointed a director by the then sole director on 2 December 2017. Therefore, in accordance with Article 18.5 of the Articles of Association, WANG Caifu, being eligible, offers himself for re-election as a director.

4. Resolution 3

HE Ping was appointed a director by the then sole director on 2 December 2017. Therefore, in accordance with Article 18.5 of the Articles of Association, HE Ping, being eligible, offers herself for re-election as a director.

5. Resolution 4

SHANG Zonggen was appointed a director by the then sole director on 2 December 2017. Therefore, in accordance with Article 18.5 of the Articles of Association, SHANG Zonggen, being eligible, offers himself for re-election as a director.

6. Resolution 5

J.K. Tan & Co., Chartered Accountants was appointed auditor of the Company by directors within three its incorporation as required by Article 35.1(b) of the Articles of Association, which further requires that:

- (i) an auditor appointed by directors on its incorporation hold office only until conclusion of the first annual general meeting; and
- (ii) the Company at every annual general meeting appoint an auditor to hold office until the conclusion of the next annual general meeting.

J.K. Tan & Co., Chartered Accountants has expressed their willingness to be re-appointed auditors of the Company.

## RIGHT TO APPOINT PROXIES

A shareholder is entitled to attend the meeting either in person or by proxy. The Articles of Association requires that:

- (1) the instrument appointing a proxy (**Proxy Form**) must be in writing and signed by the appointor or the appointor's attorney duly authorised in writing, or, if the appointor is a body corporate, by its corporate representative or at least two of its officers<sup>1</sup>, and
- (2) the Proxy Form must be received by the Company at least forty-eight hours before the meeting by delivery to the Company's office, by facsimile received at the Company's office or at any other place, fax number or electronic address specified for the purpose in the notice of meeting<sup>2</sup>.

### Lodgement of proxy form

A proxy form is attached to this Notice of Meeting.

This proxy form (and any Power of Attorney under which it is signed) must be received by the Company at an address given below by **11:00am (Western Australian time / Beijing time) on Sunday 30 September 2018**, being not later than 48 hours before the commencement of the meeting. Any proxy form received after that time will not be valid for the scheduled meeting.
