## JOHN BRIDGEMAN LIMITED (NSX:JBL) EXTENSION TO JBL OFFER CLOSING DATE

John Bridgeman Limited (NSX: JBL) refers to previous announcements regarding its takeover offers (**JBL Offers**) for all of the shares and options in Benjamin Hornigold Limited (ASX: BHD) and, in particular, to its announcement of 24 December 2018 freeing the JBL Offers from all defeating conditions.
