UNAUDITED MONTHLY PORTFOLIO UPDATE #21: JANUARY 20191

The East 72 Holdings Limited (**E72**) portfolio increased by 9.1% before costs and 8.8% before tax but after expenses during the month of January 2019. Unaudited pre-tax NTA per share at 31 January 2019 is 25.2c (27.9c after tax). E72 also has significant franking credits equating to 2.0c per share at 31 January 2019. As a guide, the Australian S&P/ASX All Ordinaries Accumulation index, increased 4% over the month.

January saw some exceptional upward moves, notably in US domiciled securities, where S&P500 rose 7.9% over the month. The initial rally from a highly fraught period immediately prior to Xmas was driven by indications of a more dovish Federal Reserve Board than previously perceived, and minor indications of some type of thaw in the US-China trade tensions. This offset the impact of the long US Government shutdown and reduction in earnings forecasts for S&P500 EPS for 2019. The 15.2% rally in S&P500 from the nadir in December (>17% for NASDAQ100) allied to reducing EPS forecasts now sees S&P500 trading at ~16x forward earnings of ~\$171. Based on the first week of the annual results season, we expect to see this number decline further, reflecting forecasts lower than the prevailing 6.1% expected EPS growth in CY2019. As a consequence, we have started to reduce our overall long exposures from the aggressive levels at end-December 2018.

We benefitted from significant positive moves in a number of banking, investment banking and other financial stocks across the globe – Sberbank +24%, Greenlight Capital +20%, Goldman Sachs +18.5% - were all notable bouncers from very oversold levels. In addition, we were assisted by a rally in the gold price above US\$1300/oz. Tesla's share price decline after the announcement of retrenchments also provided some solace.

We regard the prevailing environment as rich in opportunity. A number of perceived growth securities have rallied especially hard in the past month, and provide new short possibilities; however, we still see a significant number of heavily discounted situations. This is reflected in the larger number of holdings at present, as the short positions are generally smaller, and we in the middle of some portfolio changes. We have notably increased our short exposures in Australia where economic uncertainty, credit restriction, and an indebted, pressured consumer suffering negative wealth effects, seems not to be reflected in non-resource shares priced at 20x forward EPS.
