### John Bridgeman Limited: Disclosure query

Thank you for your letter of 18 April 2019.

While the Company's responses to your questions are set out below, the Company again queries why NSX considers that these questions are of a nature that the suspension of the Company's securities has not been lifted, particularly having regard to previous disclosures made. These questions are, in essence, requiring a compilation of historical information which has been previously disclosed by the Company in applicable market announcements and/or financial reports.

The Company, accordingly, requests the immediate reinstatement of its securities.

- (a) The Company's 'Significant Influence' (as that term is defined in AASB128) over JB Financial Group gives the Company the current ability to direct the activities that significantly affect JB Financial Group's returns;
- 1. With regard to the above, how is this achieved? What is the mechanism(s) that enables or facilitates this influence? What activities has the Company directed that affect JB Financial Group's returns?

## Response:

The Company notes that the question of consolidation of accounts is not taken lightly. The Company, taking into consideration the advice of its then auditors, KPMG, has consolidated its accounts with JB Financial Group since the half-year ending 31 December 2016. The Company refers to Note A3 in its Financial Report for the year ended 30 June 2017 which states that:

"All entities treated as subsidiaries in the consolidated financial statements are less than 50% held by JBL. The entities are consolidated on the basis of the power the Group has over investees and the extent of exposure the Group has to variable returns from investees. The Directors believe



that the consolidated Financial Report is the most appropriate presentation of the performance and financial position of the Group entities even though there is a large component of non-controlling interest (70%) in Group equity."

The Company controls 40.5% of the voting power in JB Financial Group, 7.64% through its direct investment and 32.86% exercised via the Company's control of Bartholomew Roberts Pty Ltd.

This gives the Company the power to direct activities that affect JB Financial Group's returns.

The Company reviews its corporate structure and consults with its auditors regularly in order to determine the appropriate method of preparing financial statements.
