- 4) If the answer to question 3 is yes, please provide the reason why this information was not included in the Company's response on the 24th April 2019?
- 5) Noting the above, can the Company please confirm that all responses from 24 April 2019 are complete and accurate? If not, can the Company please provide an updated response and basis for any change?
- 6) Can the Company please provide a summary of the entities within the consolidated group that Samuel Elderfield and Jarrad Stuart are or have been a director, secretary, or held a senior management position in (including but not limited to CFO) from August 2015 to present?
