UNAUDITED MONTHLY PORTFOLIO UPDATE #23: APRIL 20191

The East 72 Holdings Limited (**E72**) portfolio increased by 1.7% before costs and 1.1% before tax but after expenses during the month of April2019. Unaudited pre-tax NTA per share at 30 April 2019 is 24.0c (26.9c after tax). E72 also has significant franking credits equating to 2.1c per share at 30 April 2019.

We are strongly of the view that this is a risky period in global equities. Investors have pushed index valuation metrics to hefty levels on the back of easy central bank liquidity in most major markets, against a backdrop of insipid growth outlooks. "Less bad" seems to be the new "good" alongside the "bad news is good news" narrative maintaining risk free money at virtually no cost. The most remarkable area of this divergence appears to be in semi-conductor manufacturers where the relevant index ETF is up 36% in 2019 against a backdrop of disappointing current earnings and vastly reduced future guidance. We have accordingly taken out a small short position.

The smarter brains around appear to be taking advantage of this ebullient environment to unload large scale, branded but hefty loss-making private equity investments onto public markets – never a good sign. It might have been twenty years ago, but we have seen this play before, and it's usually not a happy ending.

We derived benefit from an eclectic group of positions – short Tesla, long Disney, Westgold Resources and Treasure ASA; we were disadvantaged by a group of short positions which over recent times have become heavily correlated, notably mid-cap Australian "growth" companies. This correlation – derived using categorised Russell 3000 index designations - is following a pattern established only over the past two years or so, of "growth" stocks dramatically outperforming their "value" counterparts when realised volatility declines to very low levels – as it has done over March and April this year. It's almost as if when volatility goes away, the "growth stocks" come out to play. This seems now to be a baked in schematic, but prior to late 2016 hasn't previously been as apparent as in recent times.

We have continued to add to selected short names as well as further hedging via index sales. However, we do continue to see cheap opportunities, noted through the "divergent" strategy outlined in the March quarterly report. As a guide, in April, we acquired new positions in Fitbit, Beazer Homes and Alliance Data Systems.
