Question 3:

The Company believes it has complied with all relevant obligations in relation to the retention of records. In relation to companies for which it acts as investment manager, the Company acts in accordance with the obligations under its management services agreements with those parties.

Question 4:

Refer to the publicly available audited accounts of Henry Morgan Limited and JB Financial Group for the year ending 30 June 2017.

Question 5:

It is important that the NSX understands that this question relates to investments made by other companies – not John Bridgeman Limited. It is not appropriate for John Bridgeman Limited to provide NSX with information relating to investments made by Henry Morgan Limited or Bartholomew Roberts Pty Ltd for release on the NSX platform.

In respect of the Investments, John Bridgeman Limited was acting as investment manager in accordance with the relevant management services agreements. It was not required to obtain the approval of the Board of John Bridgeman Limited.
