## **Placement**

a2a GN Limited (**a2a**) is pleased to announce it has successfully completed a placement of shares to new and existing sophisticated investors raising A\$58,000 before costs. The placement comprises the issue of 400,000 ordinary shares in a2a at an issue price of A\$0.145 per share. Funds raised will be utilised for general working capital purposes and for development of the blockchain and Artificial Intelligence (**AI**) technology underpinning the JomSave project.

The placement shares will be issued under a2a's existing capacity under NSX Listing Rule 6.25.
