Boon Chin Soo and Wei Yin Soo have jointly and severally agreed to provide a loan to Rofina Group Limited and its subsidiaries ("Group") capped at \$1,000,000 (interest free and unsecured) with the effect that the said directors will make sufficient funds available to the Group up to the cap as required to enable the Group to meet the Group's obligations in the normal course of business for a period of 12 months from the date Rofina Group Limited is admitted to the list of the NSX or 31 May 2022, whichever is later. Each advance is to be treated as a separate loan and payable on the business date that is at the end of five years from the date of the advance or another date by mutual agreement of Boon Chin Soo, Wei Yin Soo and the Group.
