- An offer of the securities for sale within 12 months after their issue will not require disclosure under section 707(3) or section 1012C(6) of the Corporations Act.

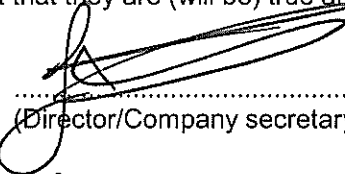
**Note:** An entity may need to obtain appropriate warranties from subscribers for the securities in order to be able to give this warranty
