

APPENDIX 2A: DIRECTOR'S DECLARATION AND UNDERTAKING

TO: The National Stock Exchange of Australia Limited

DECLARATION

I, Joshua Letcher (Royal Australian Navy 2008/11, Cert III in Mechanical Engineering Technical), an Australian, born on 28 April 1986 and currently residing at U18/29 Heard Way, Glendalough WA 6016, declare as follows

1. On 12 October 2021, I was appointed as a non-executive director of Australia Sunny Glass Group Limited (formerly Ventus Aqua Limited) (ACN 632 790 660) (**ASGG** or the **Company**).
2. I have not been, at any time, adjudged bankrupt in any jurisdiction here in Australia or overseas.
3. I have not been, at any time, a party to a scheme of arrangement or made any other form of composition with any of my creditors.
4. There are no unsatisfied judgements outstanding against me.
5. I have not been a director of any corporation that been put into compulsory liquidation or had an administrator or an administrative or other receiver appointed nor have I been a partner of any partnership that has been put into compulsory liquidation or been sequestered.
6. I have not been a director of any corporation convicted in any jurisdiction of any criminal offence or an offence under legislation relating to companies.
7. I have not been adjudged by a court in any jurisdiction to be civilly liable for any fraud, misfeasance or other misconduct in connection with the formation or management of any corporation, partnership or unincorporated institution.
8. I have not been disqualified by a court from acting as a director of a corporation, or from acting in the management or conduct of the affairs of any corporation.
9. I have not been, in any jurisdiction, been refused admission to or renewal of membership of any professional body, trade society, institution or association, or stock exchange or been censured or disciplined or had membership withdrawn by any such body to which I belong or belonged.

I, Joshua Letcher, a director of the Company (the "*Issuer*"), declare that to the best of my knowledge and belief (having taken all reasonable care to ensure that such is the case) the answers to all the above questions are true and I hereby give my authority (save where expressly provided otherwise) to the *Exchange* to disclose any of the foregoing particulars given by me to the sponsor of any corporation of which I am *director* and/or such regulatory bodies as the *Exchange* may, in its absolute discretion think fit.
