Credit Intelligence's main business model includes the provision of bankruptcy administration services and Individual Voluntary Arrangement proposal consultancy, implementation services and credit funding for corporate and individuals. I have been a director of Credit Intelligence Limited since 28 April 2020.

I am not the director or alternate director of any other corporation which is publicly listed or traded. I am not a partner in any partnership.
