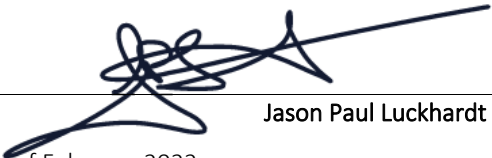

Note 6. Fair value measurement
