

## **Unaudited NTA per share February 2022**

Kaizen Global Investments Limited ("**KGI**") advises that the unaudited pre-tax Net Tangible Asset (**NTA**) backing per share of the company as at 28 February 2022 is **\$1.4789** and on a post-tax basis is **\$1.3847**.

As highlighted in the first half results, we have taken a tax charge for the sale of the private business in the audited 1H numbers, as per the accounting standards. Investors should be aware that if we make an acquisition out of the proceeds of the sale, within two years, this tax charge will not crystalise and it will be added back to the NTA.
