

NSX RELEASE 11 JULY 2022

UPDATED PUBLIC OFFER TIMETABLE AND EXTENSION OF OFFER PERIOD

Australia Sunny Glass Group Limited (**ASGG** or **Company**) (NSX: AG1) refers to the announcement dated 17 May 2022 and advises that it has today extended the closing date for its public offering of up to 21,428,571 fully paid ordinary shares (**Shares**) at \$0.35 each (**Offer**).

The Board has resolved to extend the Offer Closing Date, as specified in the indicative timetable on page 1 of the prospectus dated 16 May 2022 (**Prospectus**), by fourteen (14) business days and the Offer will now close at 5pm (AWST) on **Friday**, **29 July 2022**.

All references to the Offer Closing Date in the Prospectus are therefore taken to be updated to refer to this new date, and an updated timetable is as follows:
